Subject of Public Procurement in open procedure No. 1.2.4/2018 is selection of Private Partner and Contract award for Public Private Partnership for reconstruction, rationalisation and maintenance of public lighting on the territory of Municipality of Požega.

Type of subject: Services

The subject of public procurement according to the Common Procurement Vocabulary is:

The energy service that is subject to public procurement according to the Supplementary Dictionary is classified in Division K (Residual attributes for energy and water distribution), Group A (Properties for energy and water distribution) under:

- KA04 For electrical installations

Number of lots, if the subject of procurement is formed in multiple lots: Procurement is not formed in lots.

Criteria, elements of the criterion for awarding contract:

The selection of the best bid will be executed using criteria The most economically advantageous tender that implies the highest offered Net Present Value of the total cost of the contract.

Elements of the award criteria are:

The price, expressed through Net present value of the total cost of the contract in dinars or euros, calculated in accordance with the instructions in Chapter VI point 10 of the tender documentation;

Method of downloading the tender documentation, ie the Internet address where the tender documentation is available: www.pozega.org.rs and <http://portal.ujn.gov.rs/>.

Warranty

The bank warranty for the seriousness of the bid amounts to at least 5% of the value of the bid with a validity period of 30 days longer than the validity period of the bid.

Method of submitting the bid and deadline for submitting a tender:

The bidder shall lodge the offer directly or by mail in a closed envelope or box, closed in such a way that it can be established with certainty that it opens for the first time when opening tenders.

On the back of the envelope or on a box indicate the name and address of the Bidder.

In case a bid is submitted by a group of bidders, it must be indicated on the envelope or box that it is a group of bidders and indicate the names and addresses of all participants in the joint bid.

Bids are to be delivered to the following address: Freedom Square 9, 31210 Požega, with a note: "Bid in open public procurement for the selection of a Private Partner and contract award for Public-Private Partnership for reconstruction, rationalisation and maintenance of public lighting on territory of Municipality of Požega No. 1.2.4/2018 - DO NOT OPEN ". The bid is considered timely if it is received by the ordering party by 05.09.2018. 11:00.

Place, time and way of opening bids:

Public opening of bids is performed by the commission of the day 05.09.2018 12:00 in the building of the Municipal administration of the Požega, Freedom Square 9, 31210 Požega.

Conditions of bidder's representative participation: The opening of bids is public and can be attended by any interested person. Only the authorized representatives of the bidders can actively participate in the tender opening process. The present representatives of the bidders before submitting the public opening of bids must submit to the Commission authenticated authorizations for participation in the tender opening procedure.

Deadline for reaching a decision: A decision about the selection of the best bid shall be reached 8 days from the deadline for submitting a request for protection of rights. The contracting authority shall announce the award decision on the Public Procurement Portal and on its website within three days from the date of its adoption.
